

Competition Participation Terms

§ 1 Promotion / Raffle

Delticom AG, Brühlstraße 11, 30169 Hannover, Germany (hereinafter also referred to as "Delticom") organizes the competition. ZhongCe Rubber Group Co., Ltd. acts as the sponsor of the prizes.

Participation in the promotion is exclusively subject to the conditions listed here.

§ 2 Prize / Award

During the competition, two fuel vouchers each worth 400 GBP, will be raffled off following the purchase of 4 Goodride tyres.

§ 3 Conditions of Participation for the Competition

By participating in the raffle, the user accepts these terms and conditions. Participation in the raffle is voluntary and free of charge. Participation in the raffle is only possible in one's own name; participating on behalf of third parties is not permitted. The minimum age for participation is 18 years, and participation is limited to natural persons who are not legally incapacitated. No cash payment or exchange of the prize is allowed, even in part. The claim is not transferable/assignable.

§ 4 Execution and Processing

The participation period is from the start of the raffle on November 1, 2024, at 12:00 AM until December 06, 2024, at 11:59 PM.

To participate in the competition, the participant must purchase 4 Goodride tyres at [Mytyres.co.uk](https://mytyres.co.uk) and enter their full name and the requested contact information in the participation form on the order confirmation page and check the box "Participate in the promotion."

The person whose name the email address is registered under is considered eligible to participate. The winner will be randomly selected by a computer after the competition ends. The personal data of participants will only be collected and processed for the purpose of the promotion and will be deleted after the promotion is completed. The prize will be delivered after the end of the promotion period.

Delticom reserves the right to change, cancel, or terminate the raffle at any time without prior notice and without giving reasons. If technical reasons (e.g., viruses in the computer system, manipulation, or errors in hardware and/or software) or legal reasons prevent the proper execution of the raffle, Delticom reserves the right to terminate it immediately. The behavior of a participant can lead to the immediate termination of the raffle, especially subsequently and/or in cases of apparent lack of intention to participate, such as when the participant is a member of a so-called voting group, click community, or similar, and uses this support during participation to gain an advantage. In such cases,

Delticom may (also subsequently) exclude individual participants. In cases of subsequent exclusion, the prize will be re-drawn among all participants. Changes to the participation conditions and the termination of the raffle will be announced by Delticom on the participating website and by email.

§ 5 Data Protection, Legal Basis for Data Processing, Data Protection Regulations

Delticom AG is the data controller in terms of Art. 4 No. 7 of the EU General Data Protection Regulation (GDPR). The legal basis for all mentioned data processing is Art. 6 para. 1 b) GDPR ("performance of a contract"). We process personal data for the purposes of contest registration, execution, and handling. We collect and store survey responses for marketing purposes (e.g., to create advertising slogans or to plan marketing campaigns). During the storage period of participant responses, it is technically possible to assign the responses to the respective participants, but this is not intended. We draw general conclusions from the responses. All personal data will be stored for three years starting from the beginning of the following year, in accordance with the statutory limitation periods (storage criterion). The legality of the storage follows from Art. 6 para. 1 c) GDPR if we have to comply with statutory archiving obligations, and Art. 6 para. 1 f) GDPR ("legitimate interest"). It is in our legitimate interest to store the data for legal defense purposes until the expiration of possible claims by participants from the contest. Data processing is limited to evidentiary purposes. You have data protection rights (so-called data subject rights), in particular, the right to object to the aforementioned data processing and the right to access. § 6 Liability; Third-Party Software

Any liability of Delticom is limited to intent and gross negligence. Delticom is not liable for any manipulation or interference with the course of the raffle. This exclusion of liability does not apply to injuries to life, body, or health. The operator is not liable for problems or technical malfunctions of telephone networks or telephone connections, online network systems, servers, providers, computer hardware or software, emails, and entries that are received due to technical problems or overloading of the internet, telephone network, or a website, or a combination of the aforementioned cases. The operator is also not liable for damage to the hardware or software of participants caused by or resulting from participation in the promotion. Delticom is not liable for defects or damage to the prize.

§ 7 Exclusion from the Competition

Employees of Delticom and its associated/affiliated companies are not eligible to participate. Legal recourse is excluded. Participation in the competition is exclusively subject to the conditions listed here.
